(Established in October 2016)

Notes and Citations

1. Notes must be numbered consecutively throughout the text using superscript Arabic numerals:
The Mubarak regime⁽⁵⁾ was...in Egypt⁽⁶⁾, and...the Muslim Brotherhood⁽⁷⁾.
2. Place notes together as endnotes following the text, not as footnotes.
3. When referring to a work in the beginning of the text, provide the author's name followed by the year, page number, and table/figure number in brackets: Lapidus [1988: 35–36]. When referring to a work in the middle or at the end of a sentence, place it in brackets: [Lapidus 1988: 35–36].
4. For two or three authors, use “and”: Beinín and Lockman [1987] or Hayami, Saito, and Toby [2004]. For more than four authors, provide the first name followed by “et al.” or “and others”: Kimura et al. [1985] or Kimura and others [1985].
5. For more than two works by the same author, provide the years and page numbers of the works in brackets: Muhammad [1982; 1987a; 1988b], Muhammad [1982; 1988a, b], or Husayn [1985: 88–89; 1987: 75].
6. If the author's name is not indicated, provide the name of the publishing organization. If necessary, it can be abbreviated, although the full name should be indicated in the reference list:
In the text: HUIPS [2004]
In the reference list: HUIPS (Hacettepe University Institute of Population Studies). 2004. *Turkey Demographic and Health Survey 2003*. Ankara: HUIPS.
7. When citing a source from the internet, provide the URL address and the access date:
<http://www.shcek.gov.tr/portal/dosyalar/shcek/tarihce/t25.asp> (accessed on January 19, 2005)

Reference List

All citations in the text, including the sources for tables/figures, must be listed in the reference list alphabetically. For more than two works by the same author, list the oldest work first. For more than two works by the same author in the same year, list the works alphabetically.

Tables and figures in the text must be consecutively numbered in Arabic numerals. Place each table or figure on a separate page with its number and legend. Citation for the source of information for tables and figures must be included in the captions.
